G. Registration:

- 1. Track athletes must register with the clerk of the course when their event is called.
- 2. Field athletes must register with the event official at the venue when called.

H. Uniforms:

Uniform shall conform to National Federation Rule 4-3 (Competitors Uniform). All athletes competing must wear their school issued uniform at all times. Coaches should pay particular attention to whether their relay team's uniforms match or not.

I. Awards/Scoring:

- 1. No awards will be given at CVC track and field center meets.
- 2. Meets will be scored as double and triple dual meets.
- 3. Scoring will be as follows:

First Place – 5 points Second Place – 3 points Third Place – 1 point Relays – 5-0

J. Appeals: All appeals must be submitted in writing to the meet referee under procedures as outlined in National Federation Rule 2-3-3. (*Appendix II*)

K. Running Events:

- 1. Timed finals will be run in all running events using fast to slow heats.
- 2. In the 3200 it is recommended that the frosh/soph girls and varsity girls run one combined race and the frosh/soph boys and varsity boys one combined race.
- 3. The 800M, 1600M and 3200M will use a one-turn stagger.
- 4. The 800M, 1600M and 3200M will start in alleys.
- 5. The 1600M relay will be run as a three-turn stagger.
- 6. The 100 hurdles heights for the frosh/soph and varsity girls will be 33 inches. For the 110 hurdles the frosh/soph height will be 36 inches and 39 inches for the varsity boys.
- 7. The 300 hurdles heights will be 30 inches for frosh/soph and varsity girls, 33 inches for frosh/soph boys and 36 inches for varsity boys.
- 8. Each relay team is allowed up to six (6) members entered on athletic.net. Four team members and two alternates. This will be the same from league to Divisionals to Masters to State.

L. Field Events:

- 1. Athletes may report directly to the field event site if an event official is present.
- 2. Field event seeding will be worst to best.
- 3. In the throws and horizontal jumps each competitor will receive four attempts.
- 4. Competitors who must check out of a vertical event for another will be allowed ten minutes from the time of check out to return. Event officials should note the checkout time on their recording forms. If the vertical jumper does not return in ten minutes the bar will go up and the competition will continue.

- 5. In vertical events the event official can have the athlete who is checking out take their attempts out of order before they leave. Once the bar has been moved up in a vertical event it can't be moved down again.
- 6. For competitors who must check out in a throwing event for another event the official can move an athlete to an earlier or later flight to accommodate the athlete's absence. Once all rounds have been completed, checked out athletes can no longer be inserted into the competition.
- 7. Long Jump and Triple Jump will conduct an open pit. Competitors must be checked in by the start of the Frosh/Soph Girls 100 Hurdles. The pits will close at the start of the Frosh/Soph Girls 4 x 400 Relay.
- 8. Starting heights for the pole vault and high jump:
